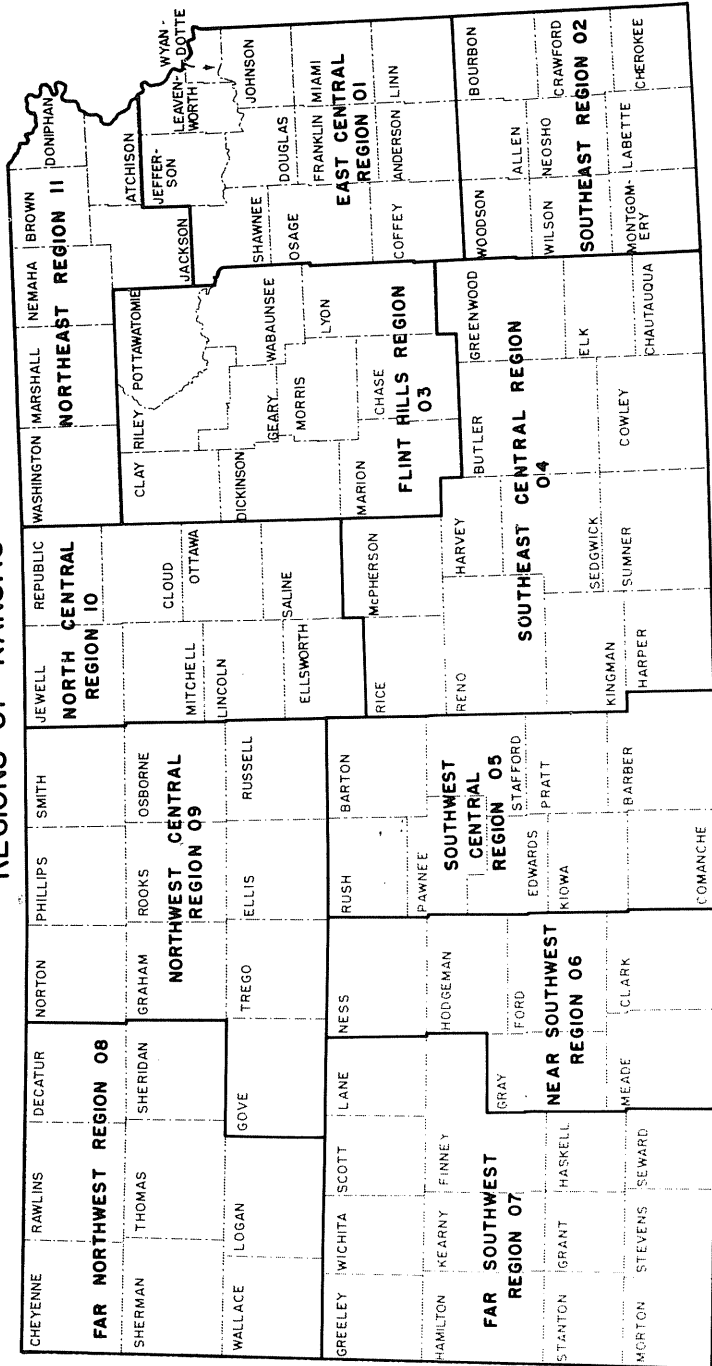

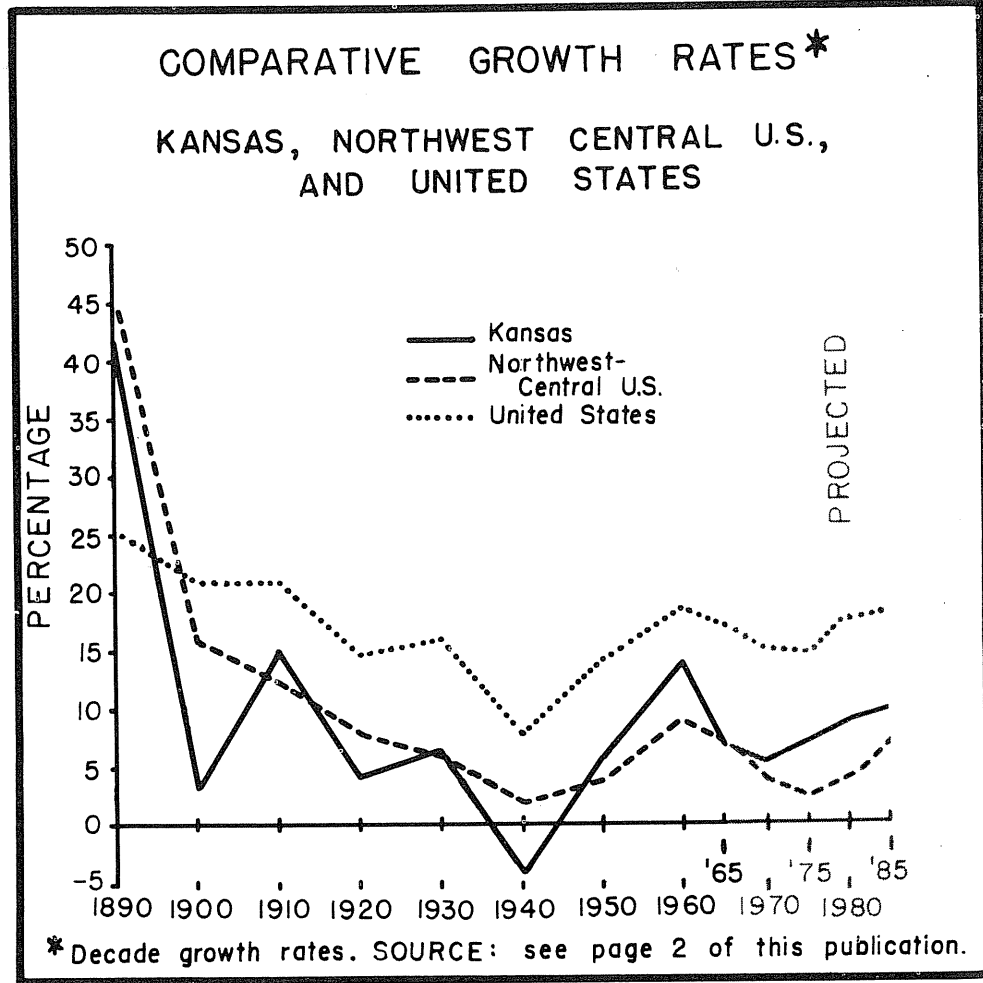

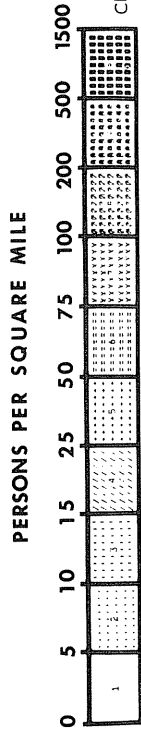

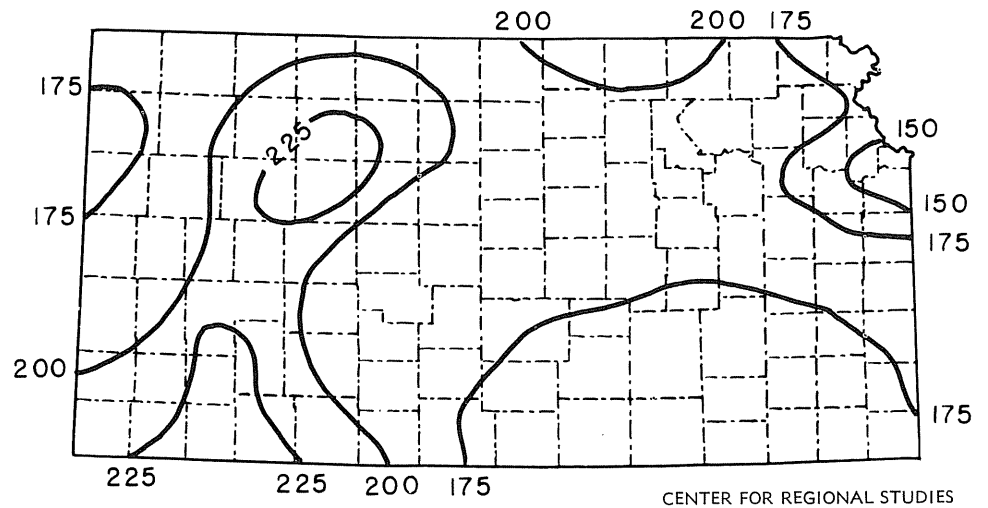

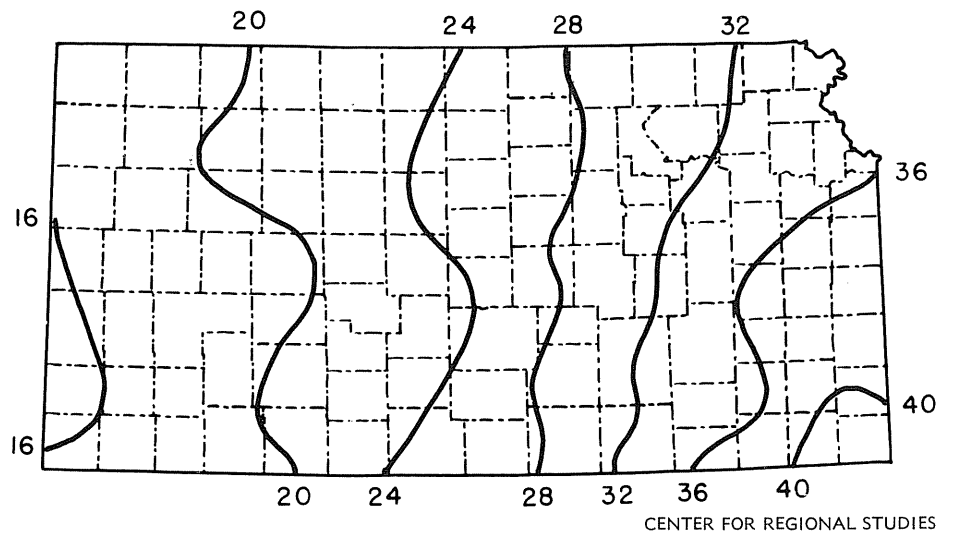

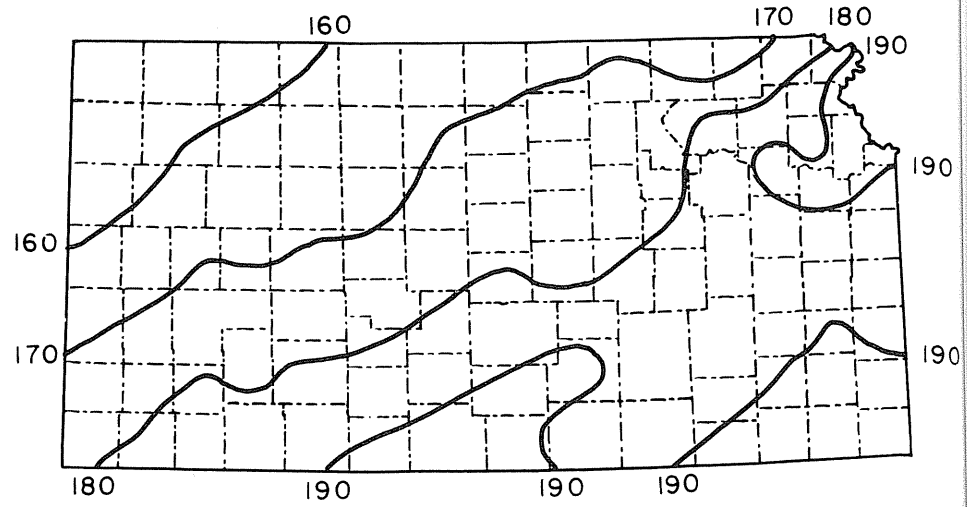
AVERAGE ANNUAL NUMBER OF CLEAR DAYS



MEAN ANNUAL PRECIPITATION, (INCHES)

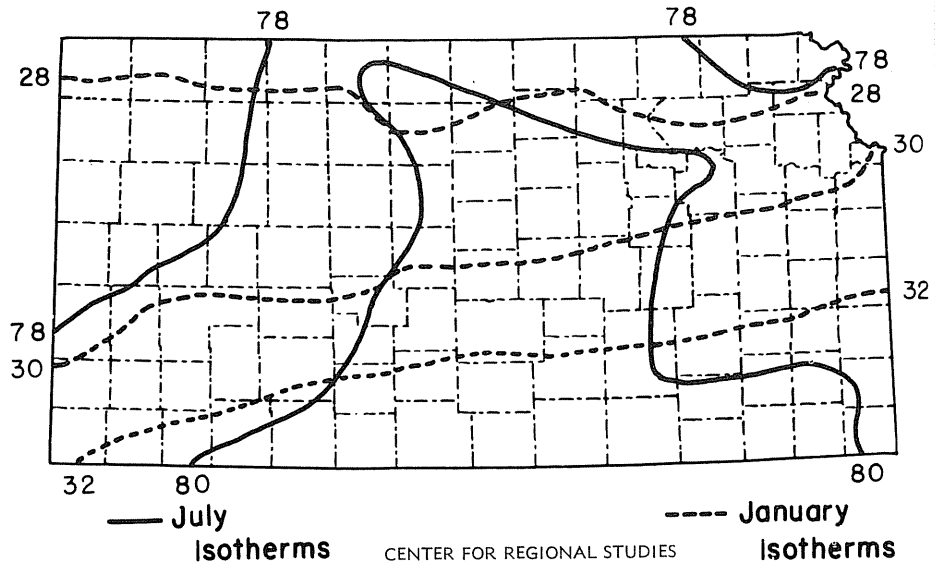


AVERAGE ANNUAL GROWING SEASON, (DAYS)

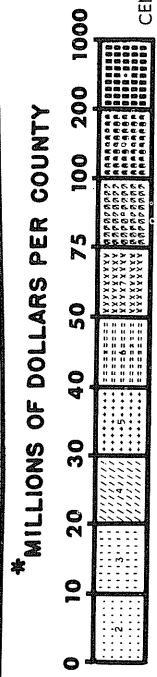
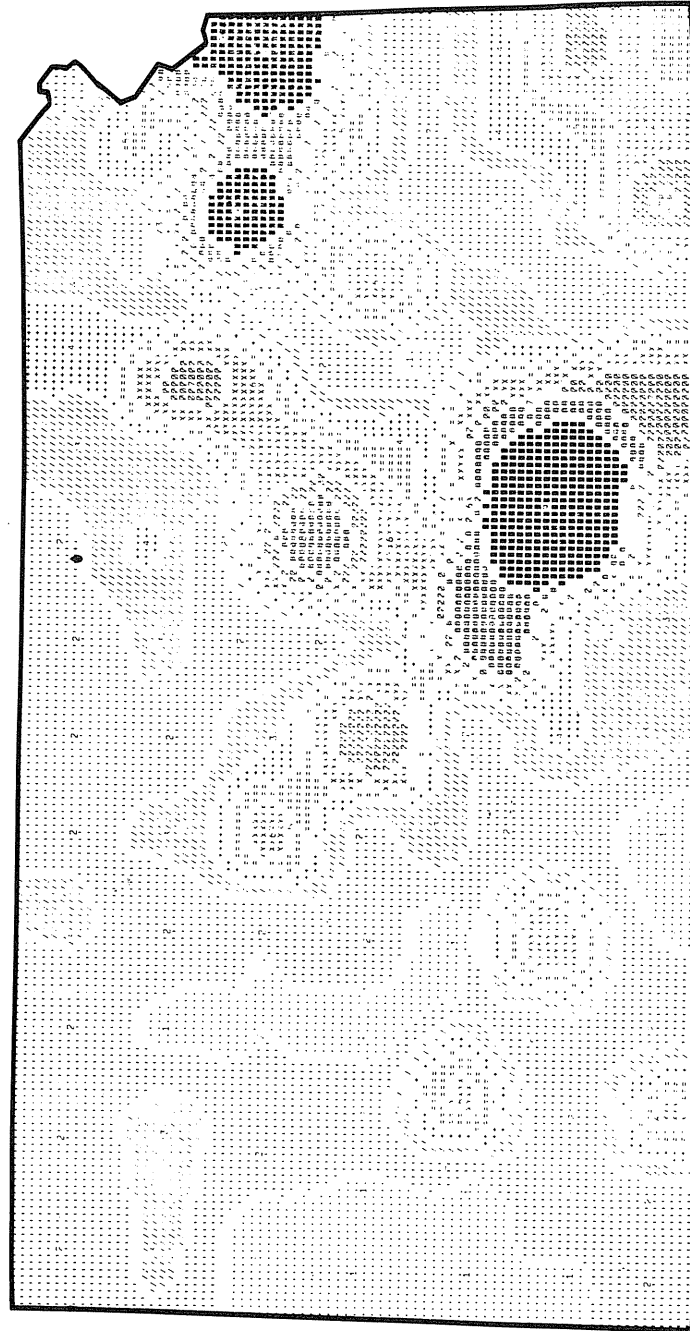

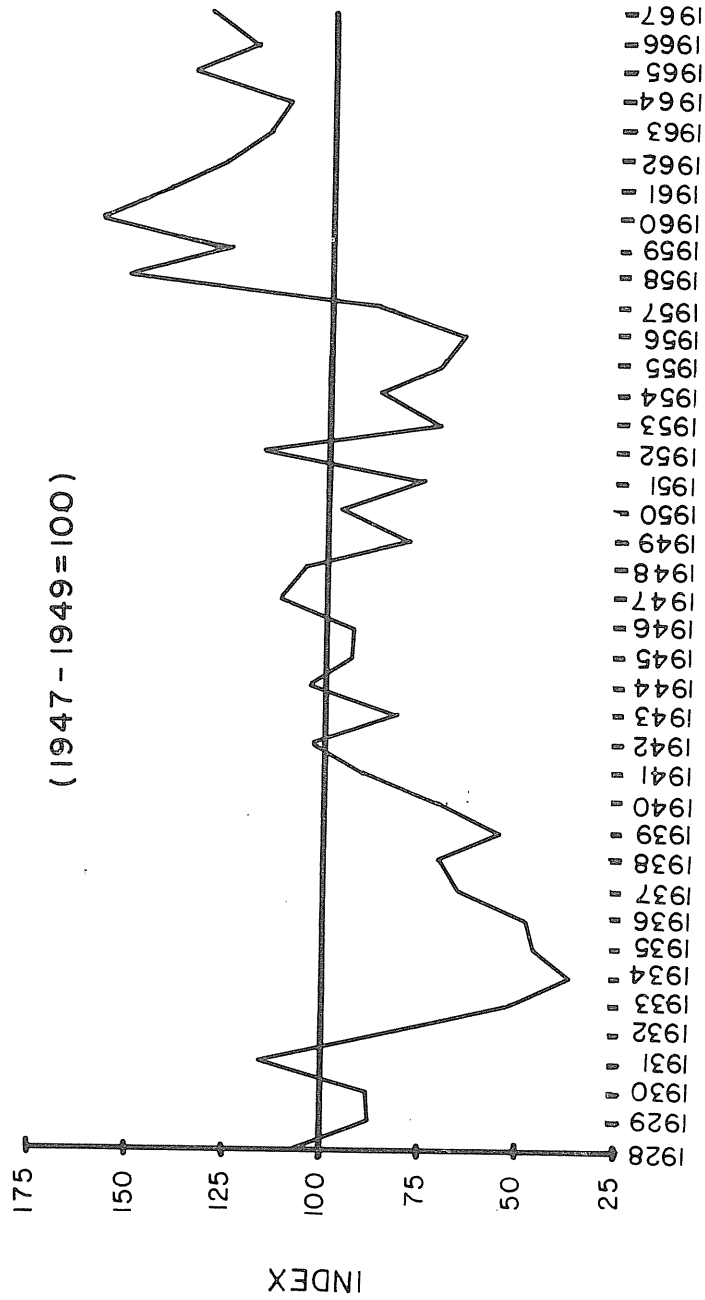
